Eastern Sierra Land Trust (ESLT) is seeking an enthusiastic, conservation-minded individual to commit to six months of service to protect Sierra natural resources and sustainable communities as ESLT's Restoration and Education Coordinator. This team member will lead and collaborate on restoration, education, and outreach projects that connect the public with the wild and working lands of the Eastern Sierra. He or she will team up with ESLT's current full-term AmeriCorps member, Sara Kokkelenberg, to work on a variety of interesting projects with a high level of responsibility and creative freedom.

The service term for this position starts on April 13, and runs through September 30. Interviews will begin shortly, so candidates are encouraged to apply soon.

ESLT has hosted talented SNAP members for 6- and 11-month terms since the Sierra Nevada Alliance began the program in 2007. These AmeriCorps members have conducted education and outreach within the region, helping to inform and inspire our communities about land preservation and habitat restoration.

ESLT has partnered to permanently preserve almost 10,500 acres of prime ranch and farmland, critical habitats, and iconic scenic vistas.
