WITH 6 NEW GARDENS CERTIFIED IN 2023, THE EASTSIDE POLLINATOR GARDEN PROJECT GREW TO A TOTAL OF 171 POLLINATOR GARDENS. POLLINATOR MIXERS WERE ALSO HELD THROUGHOUT THE SUMMER, GATHERING INTERESTED GARDENERS AND MEMBERS OF THE COMMUNITY.
